850.01 BUSINESS DEFINED; APPLICATION OF CHAPTER; EXCEPTIONS

For the purpose of this chapter, the word "business" shall mean any trade, occupation, profession, work, commerce or other activity owned, operated or conducted for profit or benefit either directly or indirectly on any premise in this City. The provisions of this chapter shall, however, not apply to societies making sales for charitable, religious, non-profit or public purposes, a producer of agricultural products selling products grown by the producer himself or herself, businesses operating as a part of a City Council approved festival or event.

850.02 REGISTRATION REQUIRED

From and after the effective date of this chapter, every business, before opening, transfer of ownership, relocating and/or operating a business in the City, or exposing his or her goods, wares, merchandise, or services for sale, shall procure from the City a business registration certificate as provided in this chapter.

850.03 APPLICATION FOR REGISTRATION CERTIFICATE; FALSIFICATION

Applications for a business registration certificate shall be in writing and shall contain a statement of facts as to the character of the business to be conducted; the location of such business; and a statement as to where the applicant has been engaged in business for the preceding two years. No person shall make any false statement in his or her application for his or her business registration certificate.

850.04 REGISTRATION FEES

Registration fees for the various classifications of businesses shall be as provided in a schedule adopted from time to time by Council resolution, and such fees shall be collected by the City before a business registration certificate is issued. (Ord. 98-02 Passed 3-17-98)

850.05 LIMITATIONS OF REGISTRATION

Notwithstanding proper registration in accordance with this Chapter, no business, profession, trade or other activity so registered is relieved from obtaining and maintaining any and all local, state and/or federal licenses, certificates, registration or other required authorization necessary to the lawful carrying on such trade, business, profession or other activity.

Proper registration under this Chapter is not, directly or indirectly, an endorsement or approval of those trades, businesses, professions or other activities and entities so registered.

850.06 VENDING AND PEDDLING RESTRICTED

There shall be no vending or peddling except as a part of a Council approved event or with a special vendor's license issued by City Council or in compliance with Chapter 862 Vendors or Chapter 863 Food Vendors.
