



## APPLICANTS NEEDED BOARDS and COMMISSIONS VACANCIES

**BOARD OF REVIEW.** One vacancy (alternate) – term ending 12/31/22. *Applicants must be a City tax paying, registered voter.* Purpose: Hears property valuation appeals.

**BROWNFIELD REDEVELOPMENT AUTHORITY.** Three vacancies – terms ending 6/30/25. *Applicants must be city residents or persons with interest in property in the city.* Purpose: Promote revitalization of environmentally distressed & functionally obsolete areas.

**COMPENSATION COMMISSION.** Two vacancies – one (1) term ending 9/30/25, one (1) term ending 9/30/27. *Applicants must be registered voters in the city.* Purpose: Establish compensation for City Council Members.

**DOWNTOWN DEVELOPMENT AUTHORITY.** Two vacancies – one (1) term ending 6/30/26 *at large member*, one (1) term ending 6/30/26 *interest member*. Purpose: Central Business district and Tax Increment Financing Authority.

**HARBOR COMMISSION.** Three vacancies – one (1) term ending 10/31/22, one (1) term ending 10/31/23, one (1) term ending 10/31/24. *Two members can be non-residents but must own real estate or a business or profession having a licensed business location in the city.* Purpose: Advisory on Marina, Harbor Development Issues.

**HISTORIC DISTRICT COMMISSION.** One vacancy – term ending 2/28/23. *Applicants must be city residents.* Purpose: Historic preservation.

**OIL & GAS INVESTMENT BOARD.** One vacancy – term ending 6/30/26. Purpose: Oversees investment of Oil & Gas Trust Fund.

**PARKS COMMISSION.** One vacancy – term ending 6/30/25 *Applicants may be non-residents but must own real estate or a business/profession having a licensed business location in the City or have a child attending school within the City.* Purpose: Advisory on parks development, maintenance, improvements, & identifying, planning, implementing public & private beautification projects.

**PEG COMMISSION.** Three vacancies – two (2) terms ending 12/31/23, one (1) term ending 12/31/24. *Applicants must be Manistee County Residents.* Purpose: Oversees operation of Manistee Public Access.

**TREE COMMISSION.** One vacancy – term ending 12/31/24. Purpose: Oversees public (parks/boulevards) tree program.

**ZONING BOARD OF APPEALS:** One vacancy – term ending 5/31/25. *Applicants shall be a representative of the population distribution and of the various interests present in the City.* Purpose: Hears appeals to zoning, building issues.
